**** RENTAL POLICIES ****

- * **The following days are considered Weekend/Holiday Rates...Monday 5/29 (Memorial Day), Monday 7/1, Tuesday 7/2, Wednesday 7/3, Thursday 7/4, Friday 7/5 and Monday 9/2 (Labor Day).**
- * **Sorry, NO Pets allowed in rental boats or on premise. Please leave them home.**
- * **NO Beaching of Boats or Towing of Anything Behind the Boat for Safety & Damage Reasons**
- * **NO refund if marina ends rental early because of unlawful behavior or unsafe boating practices.**
- * Renter/Driver **MUST** be 21 years or older, provide current driver's license & possess the ability to operate.
- * Please arrive at least 15 minutes early to allow time to check in and learn send-off instructions.
- * The person responsible for signing and paying for the rental boat must be present on the boat during rental period, unless agreed upon in advance by marina
- * Before departure, Rental Fee due according to time boat is RESERVED (or longer if available), even if renter chooses to end boat use earlier.
- * Please call ASAP if you are running late (Boats won't be held indefinitely).

**** DAMAGE DEPOSIT POLICY ****

- * Before departure, a \$250 Damage Deposit is DUE in the form of cash or credit card (If using a credit card, we ask to hold onto your actual card while you are boating). You will have the opportunity to look over & agree on boat's condition.
- * The Damage Deposit covers damage to the boat or motor, and missing equipment (anchors, oars, etc...)
- * After rental, your FULL deposit will be returned if marina staff determines no damage or missing equipment.
- * An appropriate fee will be withheld if damage occurs or equipment is missing.

**** CANCELLATION POLICY ****

- * A Late Cancellation / No Show Penalty will be charged to your credit card for **HALF** the amount of your reservation, UNLESS notice is given NO LATER than Noon the day before weekday and weekend rental (July 4th Rentals MUST be cancelled NO LATER than 72 hours BEFORE rental).
- * If renting 2 or more boats, a Late Cancellation / No Show Penalty will be charged, UNLESS notice is given NO LATER than 72 hours before rental.
- * If the Marina cancels before your rental has started for ANY reason (Weather, Equipment Problems), customer may reschedule and WILL NOT be charged Late Cancellation / No Show Penalty.

**** WEATHER POLICY ****

- * NO refund for rain, mist, or non-threatening weather -- Call to confirm the day before rental & day of, if there are weather advisories.
- * The Marina cancels ALL rental when Carver County is in Severe Weather/Wind Advisories, or when we deem boating unsafe.
- * If the Marina ends your rental early because of severe weather, a pro-rated refund will be issued to the customer via Rain Check Voucher for future rental that will be effective until 9/3/18.
